<b><u>Adopted New 19 TAC Chapter 103, Health and Safety, Subchapter CC, Commissioner's Rules Concerning School Safety and Discipline, §103.1207, Unauthorized Persons: Refusal of Entry, Ejection, Identification, and Appeal</u></b> <ul style="list-style-type: none"> <li> <b>Summary:</b> The adopted new rule provides for the implementation of provisions regarding unauthorized persons on property subject to the control of school districts under Texas Education Code (TEC), Chapter 37, Subchapter D, as amended by Senate Bill (SB) 1553, 85th Texas Legislature, Regular Session, 2017. The new rule was adopted with changes from what was published as proposed.           </li> </ul> <p><b>Effective Date:</b> August 26, 2018.</p> <p><b>Does not apply to charters.</b></p>
